The North Carolina Forestry Association has several training videos available for purchase that are geared toward the logging industry:

- 1. Equipment Care and Maintenance (12 minutes) Reviews safety, environmental and fire hazards when performing equipment maintenance. Includes lockout/tagout, preventing oil spills, fire safety and many other items. (2006) Price Code: A
- 2. OSHA Regulations (18 minutes) Reviews all required written documentation and training programs according to North Carolina OSHA standards. While North Carolina does have its own interpretation of the standards, this video can be a useful and timely review for all states. (2006) Price Code: A
- 3. Hazardous Materials Regulations (17 minutes) Covers DOT transportation, labeling, licensing and EPA storage requirements. Takes a complex issue and informs loggers what they need to know about handling hazardous materials, including diesel fuel. (2006) Price Code: A
- 4. Harvesting Procedures: Planning; Operations; Post-harvest (18 minutes) Covers pre-harvest activities such as boundary lines, contracts, SMZs, aesthetics, access, etc. then addresses fiber utilization, safety while operating equipment, truck driver placement, and concludes with tract cleanup and closure. (2005) Price Code: A
- 5. Slips, Trips and Falls/Overhead Hazards (22 minutes) Safety video covering the aforementioned topics. (2005) Price Code: A
- 6. BMPs for Timber Harvesting (2 ½ hours) Geared mainly toward North Carolina BMP guidelines, can still be used for other states. Includes a segment on what to expect from a State water quality inspection. Qualifies for 3 Category 1 CFES. (2007) Price Code: B
- 7. Load Securement for Roundwood (13 minutes) Reviews FMCSA requirements for straps/chains on treelength and double-deck wood. Includes walk-around inspection, securement guidelines and details on working load limits for securement devices. (2008) Price Code: A
- 8. Guide to Insurance for Loggers (18 minutes) Covers Workers Compensation requirements and how rates are established; general liability and inland marine insurance; loss control. (2008) Price Code: A
- 9. Threatened and Endangered Species/Critical Habitats (35 minutes) Broadcast-quality DVD aimed at showing what loggers should do if the come across bald eagles, red cockaded woodpeckers, or other rare species. Details G1/G2 terminology and describes critical habitats (caves, rock outcrops, etc.) Set up for one hour training program, qualifies for one hour Category 1 CFE. (2009) Price Code: C
- 10. Wood Chipper Safety (28 minutes) DVD reviews safe operation of mulchers, chippers and grinders. Includes English & Spanish versions. (2009) Price Code: B
- 11. CSA 2010 (18 minutes) Reviews the upcoming requirements for drivers and fleet owners for the FMCSA's new CSA program. (2010) Price Code: B
- 12. Invasive Species Stop the Spread! (50 minutes) Informative program reviews plant and insect invasive species, along with other destructive pests that are damaging our forests. Includes actions that loggers and landowners can take to lessen the impact of these pests, along with identification of major threats. (2010) Price Code: C
